### Brand New Adaptive Learning Model:

3. Self-service dashboards for employers to monitor their trainees' progress across technical learning and practical experience

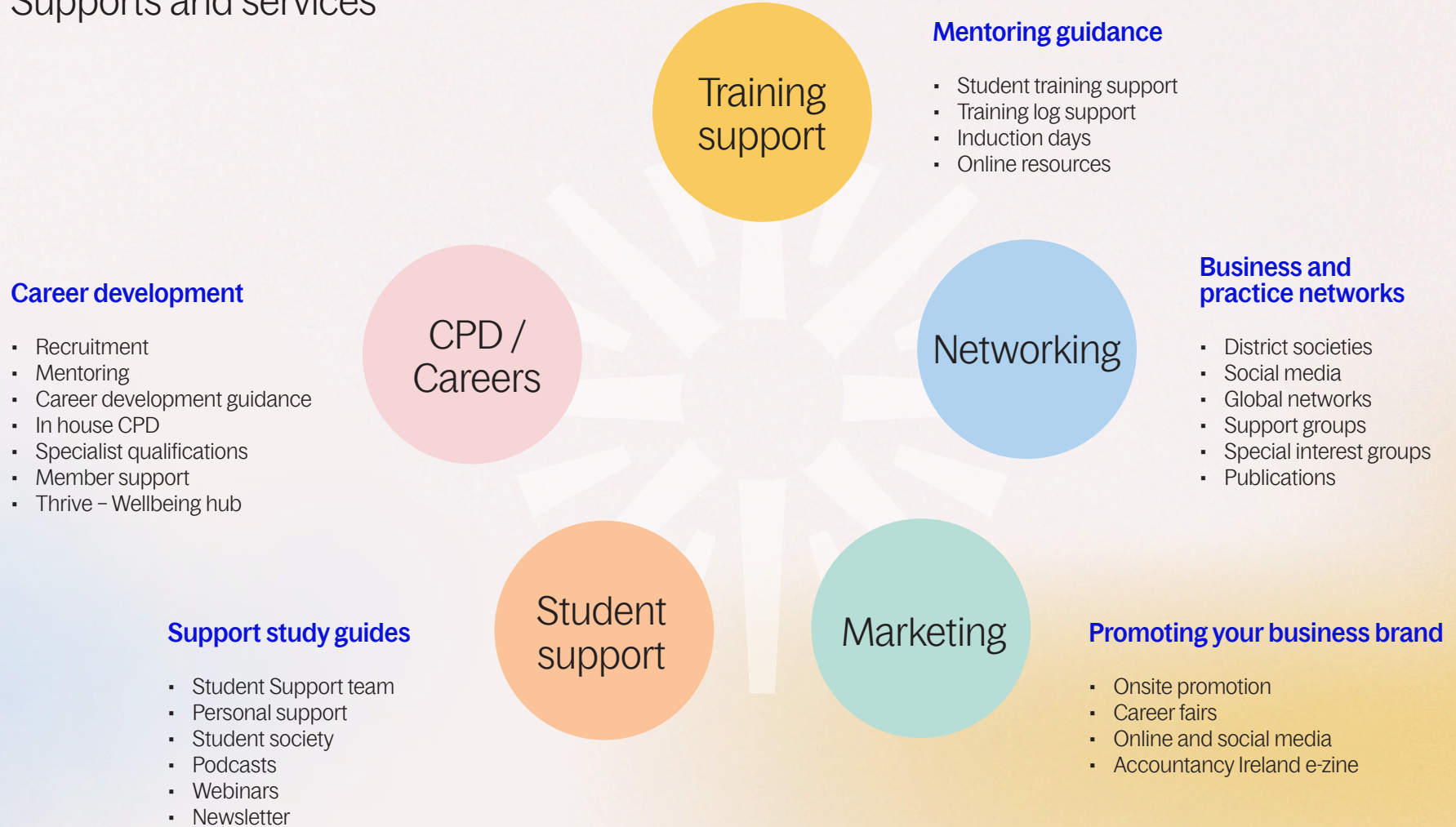
